#### How we will use the information provided in this form

This information will be used by the College during the admissions process in order to manage and assess your application and your child's suitability for a place at the College.

For example:

- a) we may contact your child's current or previous school to ask for a reference and may require a reference before an offer can be made;
- b) we may ask for information about other schools to which you are applying because they may hold their entrance exam on the same day as ours;
- c) we may contact other people with parental responsibility to check that they consent to your child joining the College;
- d) information about special educational needs and medical conditions will be used to ensure that we have made any reasonable adjustments for your child when they visit the College or during any entrance assessments; and
- e) we may share your information with credit reference agencies.

We may also need to share information with UKVI as explained above.

If your child is not offered a place, or if you do not accept the offer of a place, we will only retain this information for as long as we need to. Unless there are exceptional circumstances, information is kept for a year after the end of the admissions process. If your child joins the College we will use the information on this form in accordance with our privacy notice for pupils and our privacy notice for parents. Both of these documents will be provided to you before your child enters the College and are also published on the College's website.
